PECG represents more than 13,000 BU-9 state employed engineers, architects, geologists, land surveyors and related professionals. About 70% of our membership is employed by the Ca. Dept. of Transportation. The remaining 30% work at other State agencies such as: California Environmental Protection Agency (Air Resources Board, Water Resources Control Board, and the Dept. of Toxic Substances Control), Dept. of Public Health, Office of the State Architect, Office of Statewide Health Planning and Development, Dept. of Water Resources, Public Utilities and State Land Commissions, Dept. of Industrial Relations, Dept of Parks and Recreation, etc. The main purpose of PECG is to provide you with the most effective representation for BU-9 contract negotiations and work related disciplinary appeals, grievances and arbitrations as outlined in this link:
